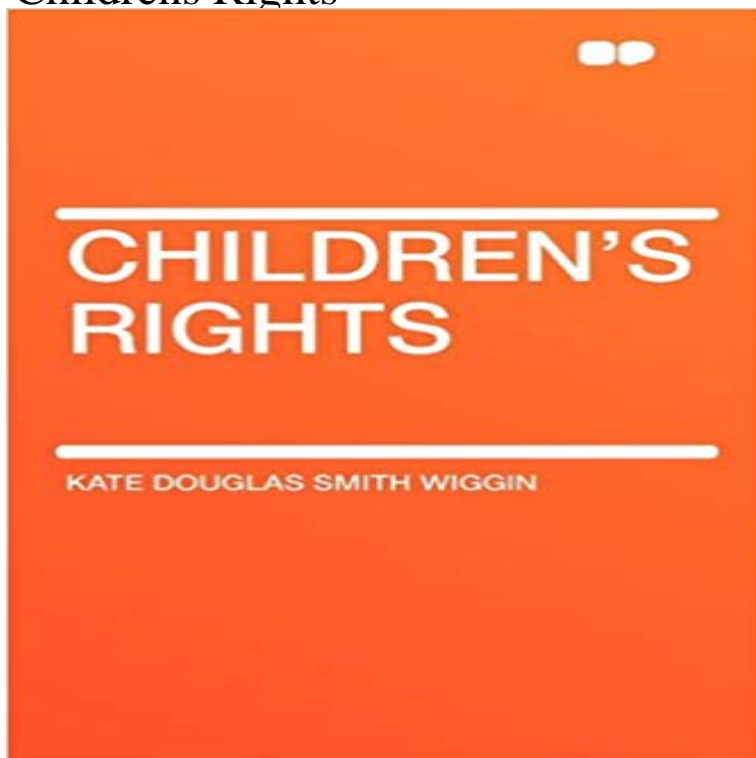


## Childrens Rights
