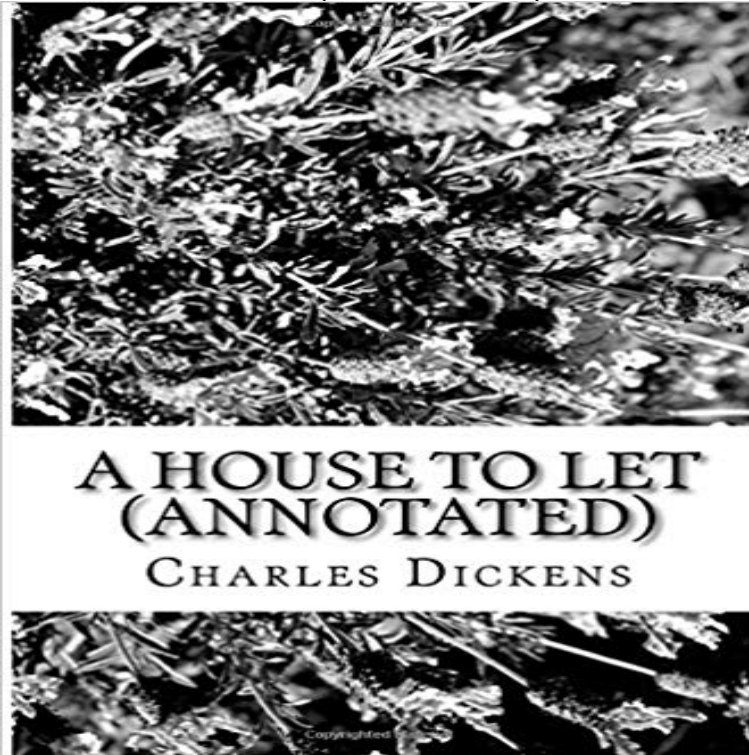


## A House to Let (Annotated)
