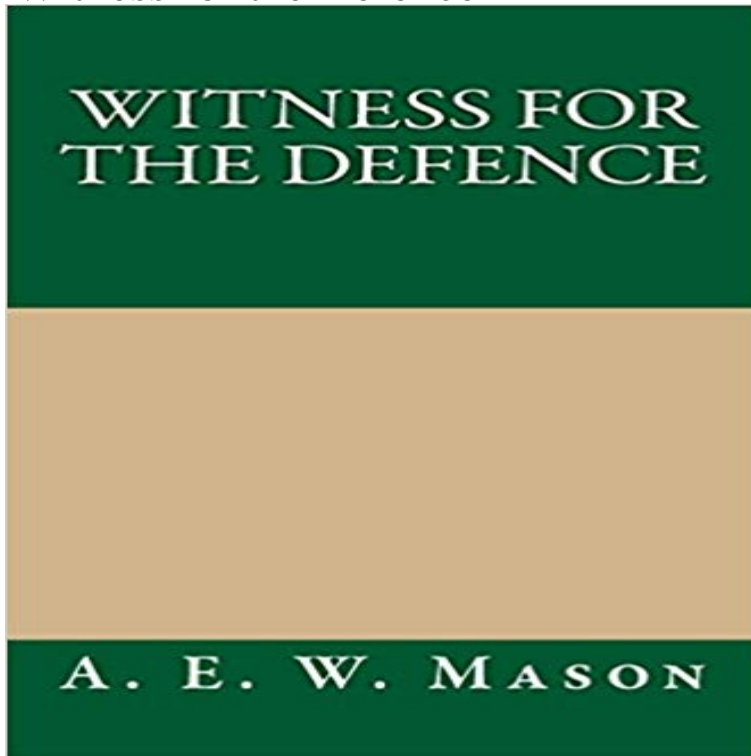


Witness for the Defence

For in the ordinary well-to-do circle, in which the Thresks lived, boys were expected to be an expense to their parents; and after all, as he argued, he had not asked to be born. And so after much brooding, there sprang up in him an antagonism to his family and a fierce determination to owe to it as little as he could.
